CDI SCHOOL ALLOWANCE

Monthly allowance will be given based on the following categories for the duration of **12 months (January 2027 to December 2027)**:

Primary	: \$60 per month
Secondary	: \$80 per month

Criteria:

1. The student must be a Singapore Citizen or Singapore Permanent Resident.
2. Gross household income less than \$2,500 per month or household per capita income less than \$650 per month.
3. Priority will be given to applicants not receiving any other grants from other organisations.
4. Application must be submitted with required documents by **1 October 2026**. Disbursement will be made through inter-bank GIRO to the student's account.

Application form must be attached with the required documents listed below:

1. Copy of NRIC or Birth Certificate (aged 15 and below) of every member of the household.
2. Copy of Student Applicant's cover page of bank's savings account (personal or joint account).
3. Copy of Marriage Certificate of parents (if married) OR Divorce Certificate of parents (if divorced) OR Death Certificate (if one or both parents are deceased).
4. Income documentation of every member of the household (excluding full-time students):

For household members who are employed

- Latest payslip/ letter from employer certifying gross monthly income; **and**
- CPF Transaction History for the past 12 months; **and**
- Latest IRAS Income Tax Notice of Assessment (NOA)

For household members who are unemployed

- CPF Transaction History for the past 12 months; **and**
- Declaration of Unemployment stating period and reason for unemployment

For household members who are self-employed, private-hire drivers and food-delivery riders

- Latest IRAS Income Tax Notice of Assessment (NOA); **and**
- CPF Transaction History for the past 12 months; **and**
- Declaration of Self-employment stating current monthly self-employment income (for self-employed persons)
- Income Slip for the last 3 months (for private-hire drivers and food-delivery riders)

5. Student card or National Servicemen identity card of siblings

IMPORTANT NOTE:

1. Cornerstone Community Services (“CCS”) respects and honours our applicants; their right to be treated courteously, fairly and have their privacy protected.
2. Please read the criteria before completing the application form. Incomplete forms or missing required documents will void this application.
3. Besides MOE FAS, students who have received other forms of assistances/ awards/ bursary such as the Straits Times School Pocket Money Fund or grants from other organisations will be given a lower priority during the selection process.
4. Please take note of the closing date for this application. CCS reserves the right to reject any application received after the closing date. **(Closing date: 1 October 2026)**
5. All successful applicants will be required to attend a compulsory awards ceremony in January/February 2027. **Failure to attend will result in the monthly allowance being discontinued.**
